Product Description

CalPro Interior/Exterior Series is a smooth flowing anti-spatter semi gloss finish for use on interior and exterior walls and woodwork in homes, apartments, condominiums and commercial applications. Cal Pro Interior/Exterior semi gloss is smooth flowing, washable, alkali & dirt resistant and suitable for most surfaces.

Recommended Use

Plaster, sheet rock, wallboard, concrete, masonry block, primed metal, primed galvanized metal, acoustical surfaces, clapboards, wood, shingles, shakes, stucco,

General Surface Preparation

Remove all peeling, blistering, loose, cracked or checked paint. Mildewed areas should be scrubbed with an EPA registered mildew eliminating cleaner then rinsed with clean water and allowed to dry. For personal protection wear rubber gloves and safety goggles during this procedure. Nail holes, cracks and voids should be appropriately filled with Spackle or caulked. Knots should be sealed with Wipe-Out ® II Alkyd Stain Block 20100.

Application

California Interior and Exterior Semi Gloss Series is easily applied, dries quickly, and provides excellent hiding for most new and previously painted surfaces and can be applied by brush, roller or spray. This application friendly semi gloss latex has excellent adhesion to properly prepared interior and exterior surfaces and resists ultraviolet rays.

Clean up

A mixture of warm water and mild soap is the best cleaning solution for water-based paints. Prepare soapy water and pour into a clean container. Dip the paint brush into the mixture, working the soap through the brush bristles. Follow with a clear water rinse. Repeat the process if necessary. Always use a clean container with clean soapy water and follow with a clear water rinse. For stubborn water-based paints, try mineral spirits or lacquer thinner, followed by warm soapy water and a clear water rinse.

1 Coat Exterior Primer Latex 46100 or Oil 23100 as substrate and conditions dictate.

1 coat FixAll Stonite Masonry Conditioner F70003
